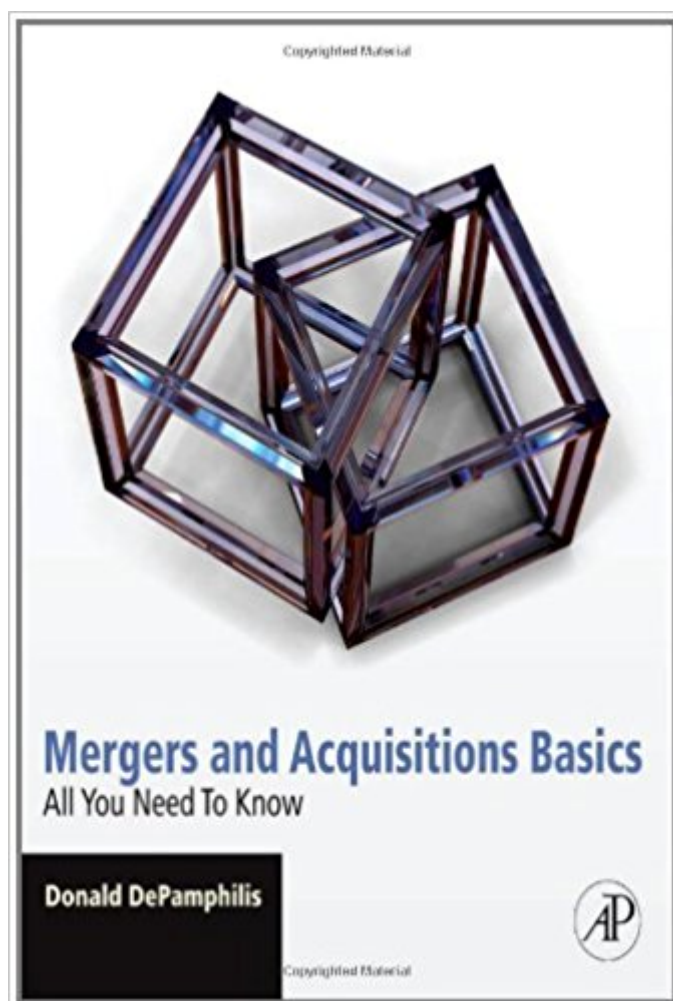

This book provides a "macro" overview of mergers and acquisitions, business alliances, and corporate restructuring. It concentrates on the processes and their players- investment bankers, business brokers, accountants, attorneys, tax experts, managers, investors, and others- and a dynamic series of actions with often-unforeseen implications. Written for those who seek an broadly-based view of M & A, this heavily illustrated mix of theoretical and empirical work eschews descriptions of individual events in favor of presenting an integrated portrait of a team effort in which the skills of various participants combine to achieve consensus among the parties to the negotiation.

Dr. DePamphilis's book entitled *Mergers and Acquisitions Basics* represents an excellent alternative to his more rigorous textbook entitled *Mergers, Acquisitions, and Other Restructuring Activities*, 6th edition, for those seeking an easy to read discussion of a highly complicated topic. The book cuts through this complexity, reducing the various activities that characterize deal making into a highly understandable process. Using relatively few graphics and virtually no algebra, *M&A Basics* in less than 300 pages describes both why and how deals are done, providing useful insights along the way. The book also provides short case studies illustrating key points related to deal making. *M&A Basics* could be extremely useful as a text in seminars or as additional reading material for classes in business strategy, business law, corporate governance, and corporate restructuring.
