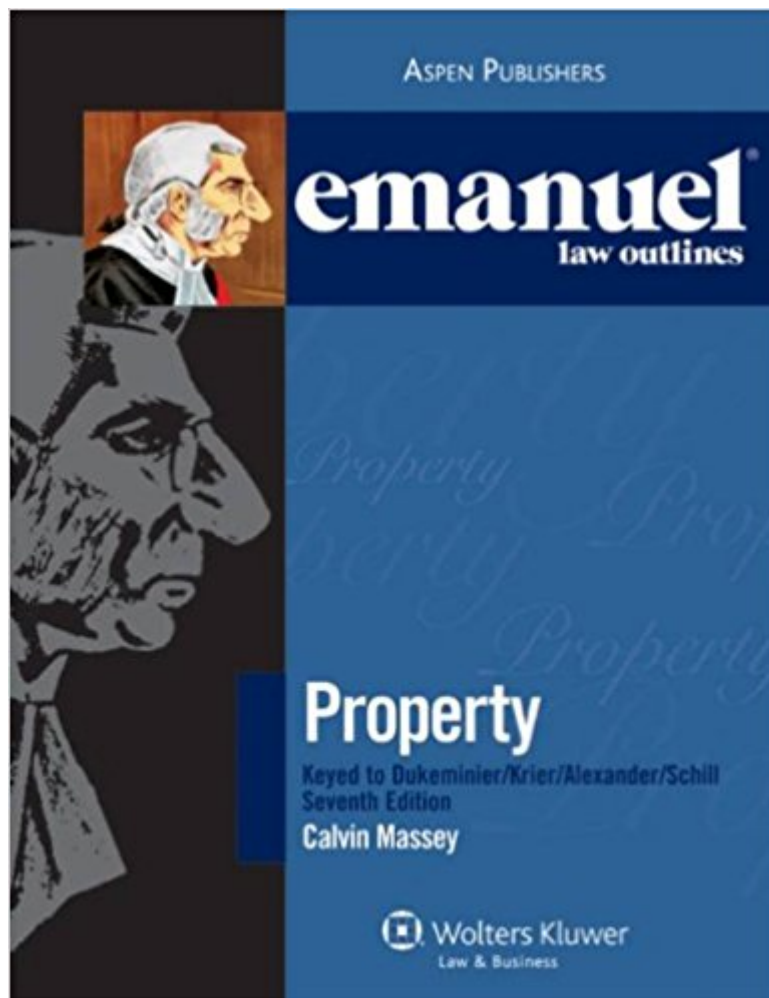

I just got this to help with my Property course which uses the corresponding casebook. I was hesitant to get the Kindle edition until I realized that I can read it on the computer. I've used it a couple of times so far and like reading it on the computer and being able to highlight. I cannot comment about the content yet, because I've just begun the course and I've never used an Emanuel Outline before. I loved that I got it at a discount at the beginning of the semester. Apparently many of the Kindle version supplements are discounted at the beginning of each semester, so keep an eye out.

This book is spot on. I have Dukeminer assigned and I like to do my readings in it and then the applicable chapters in this book. Really helpful to make sure you have not missed anything, and provides easy explanations for confusing topics. Makes understanding the textbook a breeze.

It's helpful because it is keyed to DK. I'd be careful though. Some of the stuff in here seemed to be incorrect-- or at least did not completely match up to what my professor was saying in class.

Really really helpful if you have the book its keyed to. My property professor was awful and this book does a good job laying out the issues and why we read certain cases. I ended up using it a ton to write my own outline (because my class notes were worthless). For an 8-hour take home exam this came in so handy, thank god for the index. If its not keyed to your book it will probably be moderately helpful only.

This was a great help. It matched the textbook it was supposed to. The only thing I thought it lacked was any I.R.A.C.ing. I have seen other books with the cases outlined using I.R.A.C. and that would have been helpful. But, overall this was a useful aid for understanding some of the more complex concepts. It helped simplify some material.
