

Thomas R. Dye, Emeritus McKenzie Professor of Government at Florida State University, regularly taught large introductory classes in American politics. He received his B. A. and M. A. degrees from Pennsylvania State University and his Ph. D. degree from the University of Pennsylvania. He is the author of numerous books and articles on American government and public policy, including *The Irony of Democracy; Politics in States and Communities; Understanding Public Policy; Who's Running America?; American Politics in the Media Age; Power in Society; Politics, Economics, and the Public; and American Federalism: Competition Among Governments*. His books have been translated into many languages, including Russian and Chinese, and published abroad. Dye has served as president of the Southern Political Science Association, president of the Policy Studies Organization, and secretary of the American Political Science Association. He has taught at the University of Pennsylvania, the University of Wisconsin, and the University of Georgia, and served as a visiting scholar at Bar-Ilan University, Israel; the Brookings Institution in Washington, D. C.; and elsewhere. He is a member of Phi Beta Kappa, Omicron Delta Kappa, and Phi Kappa Phi and is listed in most major biographical directories.

I first studied public policy over 20 years ago and have purchased successive editions of Thomas Dye's "Understanding Public Policy". My current library has his fifth, eleventh and twelfth editions. I have had other editions - long discarded. I was always impressed by both the comprehensivness and depth of his analysis of selected topics. Indeed I used it as a standard refernce book in formulating my views on a range of topics even though I am an Australian looking at an American academic text book. I regarded it as far superior to many local public policy books. However, I recently obtained the fourteenth edition and found that it not only repeated a lot of old material about the policy models but that its actual treatment of topics lacked the depth of previous editions. It was simply an overview lacking much of the depth and opinion which has characterised his previous works. The chapter on the Environment was particularly disappointing and he seems to have backed off his legitimate critique of global warming and the "cost-benefit" analysis of particular

courses of action. I am not suggesting that he should firmly adopt an opinion one way or the other but at least the earlier versions made one think about the topic and what students and the general reader should consider in any analysis of the subject matter, whereas the latter version is simply a summary of the topic which you could get from any number of other policy sources. I thought this edition was not as good as its predecessors.

Yes, the book, like others have mentioned, is not unbiased. You'd be advised to go into it knowing that you're going to have to read around the bias to get something out of this book. However, I imagine that if you already realize that this book is biased then you won't drink the Kool-Aid. There are things I like about this book. It is straight forward and clear. I like the fact that the author has kept chapter lengths reasonable without a lot of unneeded fluff.

This book is apparently not compatible with Kindle for PC. It can also not be used on Kindle Cloud Reader. I have no other devices in order to try and use this. I have gone through three weeks of "support" with to try and get this fixed, and the "support" has become more and more ridiculous. Just get the physical book. I just placed an order for the physical book and will be requesting a full refund on the Kindle book order.

I'm using this book to clarify public policy concepts for a graduate course. Contrary to other posts, Dye's writing style is not simple. He just avoids using all the jargon academics typically like to fill textbooks with. That jargon defeats the purpose of clarity for students. I appreciate the straight shooter writing style that is clear and easy to understand. The book is a good supplement to the more dense and difficult-to-read policy textbooks out there.

Way overpriced! This is a \$50 textbook at best. No wonder college costs keep rising!

Enjoyable read for academic pursuit. There are some unsupported statements throughout the book. Most the material, however, is factual, with applicable references. Information is presented primarily from a historical context, with little emphasis on future policy-making. Thirteenth edition does discuss recent changes in federal policy and structure, i.e. chapters on Homeland Security, and Defense Policy.
